Parent Declaration of Student Dependency

The Family Educational Rights and Privacy Act (FERPA) of 1974 prohibits Utah State University from releasing certain personally identifiable information from a student's record to a third party (e.g. parent, spouse, etc.) without the student's explicit written consent. There are two circumstances, however, under which Utah State University may disclose personally identifiable information to others: (1) an individual who knows the student's securityphrase or has been designated as a delegate on their account, or (2) by completing this form and verifying that the parent claimed the student on the <u>most recent tax return</u>.
