## CANCELLATION DEADLINES

**All cancellations need to be submitted online by logging into the Single Housing portal.**

### 2026-2027 ACADEMIC YEAR CONTRACT

**PRIOR TO APRIL 15** the \$200 housing security deposit will be refunded.

**APRIL 15 TO JUNE 15** the \$200 housing security deposit is forfeited.

**JUNE 16 TO AUGUST 22** Student must meet one on the termination reasons listed in the Housing Contract, otherwise the student is financially obligated for the contract.

**AFTER MOVING IN** Student must meet one of the termination reasons listed in the Housing Contract. Rent fees and meal plan fees (if approved) will be prorated through the date that the student completes the move-out process with HRL staff.

### 2027 SPRING SEMESTER ONLY CONTRACT

**PRIOR TO DECEMBER 15** the \$200 housing security deposit will be refunded.

**DECEMBER 16 TO JANUARY 9** Student must meet one on the termination reasons listed in the Housing Contract, otherwise the student is financially obligated for the contract.

**AFTER MOVING IN** Student must meet one of the termination reasons listed in the Housing Contract. Rent fees and meal plan fees (if approved) will be prorated through the date that the student completes the move-out process with HRL staff.

### 2027 SUMMER SEMESTER ONLY CONTRACT

**PRIOR TO APRIL 15** the \$200 security/reservation deposit will be refunded.

**APRIL 16 TO MAY 8** Student must meet one of the termination reasons listed in the Housing Contract, otherwise the student is financially obligated for the Contract.

**AFTER MOVING IN** Student must meet one of the termination reasons listed in the Housing Contract. Rent fees and meal plan fees (if approved) will be prorated through the date that the student completes the move-out process with HRL staff.

## PAYMENT DUE DATES

**FALL SEMESTER** August 20, 2026\*

Rent and meal plan charges will post on July 15, 2026

**SPRING SEMESTER** December 17, 2026\*

Rent and meal plan charges will post on November 23, 2026

**SUMMER SEMESTER** April 15, 2027 \*

Rent and meal plan charges will post on April 5, 2027

*\*pending due dates, subject to change. Due date will be the same as tuition and fees.*

## PAYMENT INFORMATION

Payment for tuition, fees and housing occur in one location simply by logging into your USU Banner Access account. Student can choose to pay with an electronic check (no additional fee added) or with a credit card (a convenience fee is added at the time of transaction). Students who will be receiving financial aid or scholarship funds will have that amount allocated to tuition and fees first. Remaining funds will be put towards any housing charges. *Please be aware* that any past due amounts on Banner, whether it be Housing or other University charges could prevent Student from registering, using activity card, etc.

## WINTER BREAK

Housing Contracts include winter break at no additional cost. Meal plans are not active during the break. Students staying during the break need to have their room keys reprogrammed at their Area Office before the end of fall semester. Students who do not remain in Housing for spring semester must complete all move-out requirements by 2:00 pm the day after finals end. Students who remain in housing during winter break and then cancel for spring will be charged a per night rate.

## AMENITIES

Electricity, natural gas, water, sewer and garbage, internet (wired and wireless), and free laundry are included. Bedrooms include extra-long twin bed (36" x 80"), dresser, desk, and desk chair. Private rooms in Blue Square have full size mattresses.

## MEAL PLANS

**REQUIRED MEAL PLAN:** Students living in Bullen Hall, Central Suites, Canyon Crest Suites, Living Learning Community and Richards Hall, are required to have a housing meal plan for the academic year.

**OPTIONAL MEAL PLAN:** Students in housing buildings other than those listed above are not required to have a meal plan. See [www.usu.edu/dining](http://www.usu.edu/dining) for information on block meal plans.

## 2026-2027 IMPORTANT DATES

<b>AUGUST 22-30</b>	Move-in dates for fall semester. Check in from 10 am to 10 pm. Meal plans begin with dinner meal.
<b>AUGUST 31</b>	Fall semester classes begin. All Students must be checked in.
<b>SEPTEMBER 14</b>	Last day to change meal plan for fall semester.
<b>NOVEMBER 1</b>	Due date to submit "Petition to Terminate Contract" for Spring semester. A \$200 late termination fee assessed if submitted after December 1.
<b>NOVEMBER 25-27</b>	Thanksgiving Break. No classes, all housing remains open. All dining services closed.
<b>DECEMBER 14-18</b>	Fall semester finals week
<b>DECEMBER 19</b>	Move-out day end of fall semester if approved for spring semester contract termination. Check-out no later than 2:00 pm.
<b>JANUARY 9-10</b>	Move-in dates for spring semester. Check in 10 am to 10 pm. Meal plans begin with dinner meal.
<b>JANUARY 11</b>	Spring semester classes begin. All residents must be checked in.
<b>JANUARY 25</b>	Last day to change meal plan for Spring semester.
<b>MARCH 8-12</b>	Spring Break. No classes, housing remains open. Limited dining options available.
<b>APRIL 28-MAY 4</b>	Spring semester finals week
<b>MAY 6</b>	Move-out date for spring semester. Residents must check out by 10:00 pm, unless they have a housing contract for summer semester.
<b>MAY 8-9</b>	Move-in dates for summer semester. Check in Noon to 4:00 pm.
<b>MAY 10</b>	Summer semester classes begin.
