Survival Analysis: Left-Truncated Data

Introduction: The random variable of most interest in survival analysis is time-to-event. Often in biomedical studies, the event is death. It is because of this common application the field is termed *Survival Analysis*. Survival analysis methods can be applied to a wide range of data not just biomedical survival data. Other time-to-event data can include: time-to-relapse of a disease, length of stay in a hospital, duration of a strike, money paid by insurance company, time-to-employment (Klein), failure times of electrical components, etc. (Survival).

There is generally a relatively short window for the duration of any study where the event is observed to occur or not occur. When the duration of study is small, adjustments must be made to account for potential biases. Useful data will be excluded when data is censored but not accounted for, and biases can be introduced when data is truncated. Since censoring and truncation are often confused, a brief discussion on censoring with examples is helpful to more fully understand left-truncation.

There are three general types of censoring, right-censoring, left-censoring, and interval-censoring. The most common type of censoring encountered in survival analysis data is right censored (Survival). In our course, we adjusted our model for the herpes data to account for right censoring. It is called right censoring because the true unobserved event is to the right of the censoring time. Left-censoring occurs when we cannot observe the time when the event occurred. For obvious reasons if the event is death, the data can't be left-censored. A good example is discussed in an ASA paper on survival analysis, "e.g. [a] study of age at which African children learn a task. Some already knew (left-censored), some learned during a study (exact), some had not yet learned by end of study (right-censored)." Interval-censoring is also discussed in *Survival Analysis: Introduction* (Survival).

Truncation is due to sampling bias that only those individuals whose lifetimes lie within a certain interval can be observed. To further discuss left-truncation we will use the motivating example on the next page. A useful insight and directly applicable to the motivating example, "Age is often used as a covariate when it should be used as a left-truncation point. When age is used as a left-truncation point, it is unnecessary to use it as a covariate in the model" (Klein).

Motivating Example: Survival data on 26 psychiatric inpatients admitted to the University of Iowa hospitals during the years 1935–1948. This sample is part of a larger study of psychiatric inpatients discussed by Tsuang and Woolson (1977). Data for each patient consists of age at first admission to the hospital, sex, number of years of follow-up (years from admission to death or censoring) and patient status at the follow-up time. Ultimately we want to know if male psychiatric patients and female psychiatric patients are more likely to die than the general public. The data from the hospitals are displayed in the table below (Klein).

The way we coded the variable death, death(0) indicates censoring time. It is important to adjust for left-truncation in this data because patients entered into the study (admitted to the hospital) have not died. This fact could bias the results, when results are compared to the general population of Iowa residents. We stratified by sex because many studies show women live longer than men so we want to compare by gender.

The following is the code used to obtain Kaplan-Meier curves, graphical representations of survival estimates. Use of the proc phreg procedure for left-truncated data is discussed in *Surviving Left Truncation Using PROC PHREG* (Foreman).
