ITEM FOR ACTION

RE: Tenure and Promotion Decisions 2025

The attached tenure and promotion decisions effective 01 July 2025 are submitted for the Trustees' consideration. They have received the appropriate administrative review and approval.

EXECUTIVE SUMMARY

Candidates for promotion and/or tenure were evaluated by faculty committees, Department Heads, and College Deans. Recommendations were then forwarded to the President for further consideration. After review by the President, Provost and Executive Vice President, Vice President for Research, Vice President for Extension, and eight faculty members, ninety-one faculty are recommended for promotion and/or tenure to become effective 01 July 2025.

The candidates include: 1) sixteen assistant professors promoted to associate professor with tenure; 2) thirty-two associate professors with tenure promoted to professor; 3) seven extension assistant professors promoted to extension associate professor with tenure 4) seven lecturers promoted to senior lecturer; 5) six senior lecturers promoted to principal lecturer; 6) ten professional practice assistant professors promoted to professional practice associate professor; 7) two professional practice associate professors promoted to professional practice professor; 8) three professional practice extension assistant professors promoted to professional practice extension associate professor; 9) two research assistant professors promoted to research associate professor; 10) two research associate professors promoted to research professor; 11) one clinical assistant professor promoted to clinical associate professor; 12) two clinical associate professors promoted to clinical professor; 13) one assistant librarian promoted to associate librarian with tenure.
